

Boscawen Selectmen's Regular Meeting  
Final Meeting Minutes 04.26.17

Selectman Varney opened the meeting at 4:32pm, led us in the Pledge of Allegiance and a moment of silence.

A concern was brought before the board in regard to a high water and sewer bill. This resident had not yet contacted the water precinct, Selectman Varney suggested that he does so as they would be the appropriate office to speak to.

\*Amendment to Selectmen's minutes from April 5, 2017: **Fire Department, Chief Fisher:** Wilmot training had occurred as scheduled.

Board of Selectmen public minutes from April 12, 2017 were presented for approval by Pennie Vigue, Administrative Assistant, Selectman Varney moved to accept the minutes with amendments, Selectman Sanborn seconded that motion, all in favor.

Board of Selectmen public minutes from April 19, 2017 were presented for approval by Pennie Vigue, Administrative Assistant, Selectman Varney motioned to accept the minutes with amendments, Selectman Davis seconded that motion, all in favor.

Board of Selectmen non-public minutes from April 19, 2017 were presented for approval by Pennie Vigue, Administrative Assistant, Selectman Davis moved to accept the minutes, Selectman Sanborn seconded that motion, all in favor.

**Co-Administrator, Nicole Hoyt:** Nicole stated that the minutes from March 29, 2017 would be ready for approval next Wednesday May 3, 2017. Citizen's Bank is removing the ATM machine from the hallway of the town offices due to lack of monetary gain. Deeding is this coming Friday, three, none waived, all approved to move forward Friday at 4:30pm. A complaint was received in regard to a bump in the handicapped ramp outside of the Town Offices, Selectman Davis will see if he can get someone to level this out.

**Planning and Community Development Assistant, Kellee Easler:** Kellee had one refund abatement, all in favor, signed. A charitable exemption for Penacook Masonic Association, denied, all in favor. Riverbend charitable exemption, approved, all in favor. Community Bridges charitable exemption, approved, all in favor.

**Town Clerk, Michelle Brochu:** Registered 20 dogs today. Requested approval for Pennie Vigue to take the course to become a municipal agent for the DMV, approved, all in favor. May 10, 2017 motor vehicle at the Town Office will be closed. This information will be put on the website.

**Fire Chief, Ray Fisher:** The Boscawen Police Department has given an ATV to the Boscawen Fire Department, Jason Killary will have this registered with N.H. Fish and Game. EOP fire night was on Monday, 18 people were there, and Ray stated it went very well. The Smokey the Bear sign has begun being updated daily. Nicole Hoyt questioned whether or not we could put a link to the D.R.E.D.S. on our website.

**Public Works, Dean Hollins:** Dean stated that he has scheduled Hardy Lane to be graded. Three trees need to come down. Monday morning they lost a pump on one of the trucks and a starter was also replaced in a pick-up truck. Nicole Hoyt stated that there is a sign leaning on Lincoln and Park Street and that there is also a tree leaning in that area. The parks and recreation building did experience some flooding, a curb stop will be going in.

**Police Lieutenant, Jason Killary:** Updated the board on two untimely deaths a couple of weeks ago, one suspected overdose and one probable overdose. There were two untimely deaths today. Jason also spoke of Carfentanil. This is a new drug that has been confirmed to be present in N.H. The drug is an elephant tranquilizer, transdermal and airborne. The drug has been linked to three N.H. deaths last month. Carfentanil is 100 times more powerful than its counterpart Fentanyl.

**Motion to adjourn public session was made by Selectman Davis, seconded by Selectmen Sanborn, motion approved at 5:27 pm.**
