The regular meeting of the Cemetery Trustees was called to order at the Boscawen Municipal Facility, 116 North Main Street, Boscawen, N.H. on April 17, 2024, at 9:05 a.m.

Approval of minutes from last meeting:

The Cemetery Trustees read and reviewed the Draft Minutes from March 20, 2024. *Beverly Lacoy made a motion to approve the Regular Meeting Minutes of March 20, 2024. Seconded by Rhoda Hardy. Passed Unanimously.*

Old Business:

- 1. Reminder NH Cemetery Association Spring Meeting April 18, 2024:** Lauren Hargrave reminded the Cemetery Trustees about the NH Cemetery Association Spring Meeting, which is to be held tomorrow, April 18, 2024, from 8:30 a.m. through 12 p.m. at the Derryfield in Manchester, New Hampshire. The Cemetery Trustees reviewed the agenda for the meeting. A discussion took place regarding who was attending and who would be driving. Rhoda Hardy, Lauren Hargrave, and Beverly Lacoy will all be attending. Lauren Hargrave will be the driver and will pick both Rhoda Hardy and Beverly Lacoy up at their homes at 7:40 a.m. It was noted that the registration paperwork was previously sent in with payment by the Town of Boscawen and Dean Hollins was not attending as he is on vacation.

New Business:

- 1. Cemetery Graveyard Workshop:** The Cemetery Trustees reviewed the 2024 Cemetery Graveyard Workshop flyer. The workshop will be held June 15, 2024 at 10:00 a.m. at Dunbarton Center Cemetery. The workshop is sponsored by Dunbarton Cemetery Trustees in conjunction with the New Hampshire Old Graveyard Association. Rhoda Hardy read from the flyer the following will be covered at the workshop: Learn the proper way to straighten leaning headstones. How to re-seat a headstone whose top is no longer attached to the base. Learn how to repair a broken headstone and the proper product to use. Lauren Hargrave stated that because the

workshop will be held on a Saturday, perhaps Dean Hollins can attend and be paid through the Cemetery budget. Rhoda Hardy stated that all of Dean Hollins employees should also go, or at least one of them. The Cemetery Trustees all agreed to table this discussion until next month's regular meeting when it will be revisited.

- 1. Fritz Clifford:** Rhoda Hardy questioned if there was anything the Cemetery Trustees needed to do with regards to Fritz Clifford.
