**Department Head Updates:** Chairman Burdick read the motion into record for the first fiscal year (2024) sewer bill warrant. *In the name of the state, you are hereby directed to collect the charges in the list here within committed to you, amounting in the sum of \$57,044.79 and with interest at 8% per annum from February 28, 2024, and thereafter on all sums not paid on or before that day. Furthermore, to remit all monies collected to the Town Treasurer or Town Treasurer's designee as provided by RSA 41: 29 6 at least on a weekly basis or daily whenever tax receipts total \$1,500 or more from September 10, 2023, through December 8, 2023.* 

Chairman Burdick motioned to approve Town Clerk Nicole Hoyt to collect \$57,044.79 for the first FY24 sewer bill warrant. Seconded by Selectwoman Carey. Roll Call Vote. All in favor. None opposed.

Town Administrator Katie Phelps met with Derek Martel from Primex Insurance to review their audit findings. Primex recommended a cybersecurity assessment through the government's Cybersecurity and Infrastructure Security Agency (CISA) which would be free. They also recommended the town develop passphrases for more protection. TA Phelps will work with
