If any others come up, they can be 27 discussed and brought forward to the Select Board. 28 Do no work on the Circle but continue fundraising: None were in favor of this option 29 30 Public Works to remove pile and place "Welcome to Boscawen" sign: None in favor of this 31 option 32 Erect flagpole: Option 1 with additional items, see below. Lay sod plant flowers: Sod/grass and plants will not survive the winter, no water or maintenance 33 available. Money not well spent, extensive maintenance to establish into soil. None of the 34 35 Committee recommends or agrees with grass or sod. Complete the 3 12' stone walls: Bev Drouin will go back to stone mason and discuss a more 36 37 inexpensive options. Granite will not be an option due to NHDOT, no breakaway.
