August 7th will be the meeting where we discuss health and medical. Olin Garneau has received confirmation from the American Red Cross and Public Health Network that they will attend that meeting.

TA Phelps worked with Finance Director Merrill to get staff fringe rates for time tracking.

Ms. Garneau asked EMD Killary if he had collected any certificates of training from anyone. He noted he has not. Certificates of training from October 1, 2021 through August 2024 with ICS or NIMS or any other emergency preparedness training certificates can count towards the match. That is only as long as they haven't been used for other grants.
