Peter Dodge- Mr. Dodge came to meet with the Committee to discuss being in the Parade to celebrate the 100th year of the American Legion. Mr. Dodge said that Veterans, Cadets, Boy Scouts and Girls Scouts will all be marching along with them. Mr. Dodge said that the Cadets will be carrying the colors for the Legioniers. Mr. Dodge said that the Ryders is a motorcycle group that will be with them and asked if they could lead up the rear of the parade. Mr. Cherian said that the Fire Trucks usually are last. Mr. Dodge said that they can follow behind them. Mr. Dodge also said that they will have cars and two floats one that has posters and one carrying Veterans. Mrs. Dawson said she will send an informational packet along to him. Polly Dawson questioned if the Committee would like to do a theme that went along with celebrating the 100th year anniversary of the American Legion.

<u>MOTION</u>: Polly Dawson made a motion for the theme for 2019 to be Thanks to the American Legion for 100 years of service. Seconded by Beverly Lacoy. All were in favor. None opposed.

<u>Minutes-</u> Rhoda Bergeron said it should be added that a police officer should be present from 12-1.

Financial Report- Lyman Cousens said there is \$20,866.65 in the account. Lyman said that Bingo netted about \$2300. Matt Lampron said that his expenses were about \$400.

<u>MOTION:</u> Polly Dawson made a motion to accept the profit and loss sheet as of April 15th. Seconded by Lyman Cousens. All were in favor none opposed.

<u>Member Update-</u> Polly Dawson said that not all the members are current and Rhoda and Beverly need to be reappointed as members. Polly said the website will need updating as well.

<u>MOTION:</u> Polly Dawson made a motion to appoint Rhoda Bergeron and Beverly Lacoy another 3 year term. Seconded by Lyman Cousens. All were in favor. None opposed.

Golf- Lyman Cousens said he will be discussing with Elektrisola next week and they discussed having an animal show at Winthrop Carter House. Lyman Cousens said that Dan Zaines does a show here in New Hampshire once a year and he is friends with his mother. Lyman said he will investigate if Dan could attend Old Home Day. Mr. Cherian said that he can pass out sponsor sheets. Kim Kenney said they should challenge all the Town Departments to sponsor a hole.

Old Home Day- Matt Lampron said that he and Kim will be meeting with Crete Farm and asked Kim to set up the meeting. Kim Kenney said that there will be a Fire Truck, Heavy Equipment Vehicle and Police Cruiser at the field then suggested doing time slots for different performers such as a magician, a juggler or some other form of entertainment. Matt Lampron said that the estimated cost of Old Home Day is \$12,580. Polly Dawson said the parade is \$5,000. Mrs. Kenney said they will do the bungee, small bounce house and water slide. Mr. Cherian asked the Committee to decide if they would like the Merrimack Baseball League to do the food or if they wanted to cook. Matt Lampron said that having enough people for the food is an issue. The Committee discussed having an open mic and getting a sound system, possibly hiring a DJ. Rhoda Bergeron said she has a small sound system and they could try it. Matt Lampron said that they should have a similar menu like hot dogs, hamburgers, pizza, popcorn, soda and water. Matt Lampron talked about if they have the baseball team sell food they are going to charge more. If they won't to provide food for a cheaper cost the Committee will have to pay the difference and it will end costing money to provide food. Matt Lampron suggested shutting down food from 4-6pm so everyone can get a break. The Committee agreed this was a good idea.
