They gave different scenarios of how this could work out and that it may need to be changed. They have also stated that there will be 15 feet between each of the buildings.

Mr. Crawford added that he thinks it would be best to try and put the buildings where they will end up. This will eliminate less phases and cut their expenses.

Mr. Hardy asked the board with the future phases, how should this be done and will it need to meet with TRC again? Discussion ensued regarding if it should go to Planning Board, then possibly TRC for Phases.

It was decided to have Mr. Caron and Mr. Leonard draw up their proposed plans and then submit to the Planning Board.
