2001 PERAMBULATION BETWEEN THE TOWNS OF BOSCAWEN AND WEBSTER, NEW HAMPSHIRE

Pursuant To a mutual agreement between the Selectmen of Boscawen and the Selectmen of Webster for their representatives to meet on the 20th day of October 2001 for the purpose of perambulating the line between said towns and reviewing and renewing marks and bounds according to law, we the subscribers met for the aforementioned purpose and make the following report:

We met on Deer Meadow Road at the Concord-Webster line, and proceeded approximately ¼ mile along a stone wall which is the dividing line between Concord and Webster. The stone monument is approximately 2' tall and is marked "TLBW 1868" (Town Line Boscawen & Webster) and is the southwest corner of Boscawen.

From this corner, the town line runs northerly 12° 03'52" west in a straight line 12,210 feet (740 rods) to a stone monument on the south side of Corn Hill Road. marked "TLBW 1867." The town line runs westerly beside the road 1,686.3 feet (102 2/5 rods) and continues as the center line of Pond Brook; it then goes northerly and crosses Walker Pond to the northerly end. It then continues in a straight line across Couch Pond, and continues to run northerly following the center line of Beaver Dam Brook.

The next bound is on Mutton Road in Webster, approximately 150' (approx. 9.09 rods) south of its intersection with Beaver Dam Brook. From this point, proceed westerly on a wood road to the power line right-of-way two thirds of the distance between the poles marked #947-452 and #946-451. Go east on a path approx. 1/8 of a mile to Beaver Dam Brook. The stone monument is 16½ feet (1 rod) west from the center line of the brook. At the time of this perambulation, only the top 6" of the stone was above the surface of the water and is further marked by a yellow iron T-pipe set at this time beside said stone. The actual boundary line is in the middle of the brook and is marked only by the offset stone, which is marked "TLWB."

For the benefit of those who will do future perambulations, it is noted that 4-wheel drive vehicles are necessary, (since bushes and mud are inevitable) and it would be useful to carry tape measure, red tape and/or stray paint to mark trails, camera to record locations, etc., and flashlight (to read markings).
