Discussion regarding the January 28, 2020 case regarding an RV on Route 3 belonging to Justin West. Mr. West was deployed as part of the National Guard in relation to the COVID19 pandemic. Easler reported that the Board of Selectmen discussed this last week and are willing to extend the amount of time he has to remove the RV from 90 days to 180 days. She believe that would take him to the end of July for removal. It was noted that if he is deployed for longer than that, they would discuss extending the time frame again. Cherian asked that the letter that will be written by the Select Board to be shared with the Zoning Board members.

Supry mentioned that the Board is short on members. He thought perhaps Roger Sanborn was interested in becoming a member. Cherian offered to call Mr. Sanborn if the Board would like.
